**SPORT PARTICIPANT RELEASE of LIABILITY of CLAIMS,

Express Assumption of Risk Associated with Sport, Venue Use and Related Activities.  
Participant/Competitor must sign in order to participate in event.**

I, \_\_\_\_\_ (print name) do hereby affirm and acknowledge that I have been fully informed of the inherent hazards and risks associated with the "1<sup>st</sup> Annual Da Hui Waimea Bay Shorebreak Slam 2010", transportation of equipment related to the activities, and traveling to and from activity site in which I am about to engage.

**Inherent hazards and risks include but are not limited to:**

- 1) Risk of injury from the activity and equipment utilized is significant including the potential for broken bones, severe injuries to the head, neck, and spinal cord or other bodily injuries that may result in permanent disability and/or death.
- 2) Possible equipment failure and/or malfunction or misuse of my own or other's equipment.
- 3) I AGREE THAT I WILL WEAR APPROVED PROTECTIVE GEAR AS DECREED BY THE GOVERNING BODY OF THE SPORT I AM PARTICIPATING IN. However, protective gear cannot guarantee the participant's safety. I further agree that no helmet can protect the wearer against all potential head injuries or prevent injury to the wearer's face, head, neck or spinal cord.
- 4) Variation and/or steepness of terrain, variation or changes in surfaces including surf, bare spots, rocks, stumps, debris, padded & non-padded barriers, other persons, and other natural and/or man-made hazards.
- 5) My own negligence and/or negligence to others, including but not limited to operator error and guide decision making including misjudging terrain, waves, weather, riding surfaces and/or other obstacles.
- 6) Exposure to elements and temperature extremes may result in heat exhaustion, heat stroke, sunburn, hypothermia & dehydration.
- 7) Dangers associated with exposure to natural elements include but are not limited to rock fall, inclement weather, thunder & lightning, severe and/or varied wind, ocean, surf, temperature and other weather conditions.
- 8) Accidents or illness in remote places where there are no available medical facilities.
- 9) Fatigue, exhaustion, chill and/or dizziness, which may diminish my reaction time and increase the risk of accident.
- 10) Impact or collision with other athletes, spectators, facility employees, pedestrians, motor vehicles and cyclists.

**\*I understand the description of these risks in not complete and unknown or unanticipated risks may result in injury, illness and/or death.**

**Release of Liability, Waiver of Claims and Indemnity Agreement**

In consideration for being permitted to participate in the above described activity(ies) and related activities, I hereby agree, acknowledge, and appreciate that:

- 1) **I HEREBY RELEASE and HOLD HARMLESS with RESPECT to any and all injury, disability, death, or loss or damage to person or property, WHETHER CAUSED by NEGLIGENCE or OTHERWISE**, the following named person herein referred to as releases: Hui O He'e Nalu (aka: Da Hui), Da Hui, Inc., Da Hui, Intl, City & County of Honolulu, State of Hawai'i and all event sponsors and employees.
- 2) To release the releasees, their officers, directors, employees, representatives, agents, and volunteers from liability and responsibility whatsoever and for any claims or causes of action that I, my estate, heirs, survivors, executors, or assigns may have for personal injury, property damage, or wrongful death arising from the above activities whether caused by active or passive negligence of the releasees or otherwise. By executing this document, I agree to hold the releasees harmless and indemnify them in conjunction with any injury, disability, death, or lost or damage to person or property that may occur because of my engaging in the above activities.
- 3) By entering into this agreement, I am not relying on any oral or written representation or statements made by the releasees, other than what is set forth in this Agreement.
- 4) This Agreement shall apply to all injury, disability, death or loss or damage to person or property occurring at any time after the execution of this agreement.
- 5) I understand that at this event and other related activities, I may be photographed. I agree to allow my photo, video or film likeness to be used by the releasees, producers, sponsors, organizers and or assigns, without compensation or reservation.

This release shall be binding fully permitted by law. If any provision of this release is found to be unenforceable, the remaining terms shall be enforceable. **I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, I FULLY UNDERSTAND ITS TERMS THAT I HAVE GIVEN UP LEGAL RIGHTS BY SIGNING IT, AND I SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.**
