RELEASE / WAIVER

I am aware that there are hazards that may exist in connection with my participation in competition and I voluntarily participate in this activity with knowledge of those hazards. I also assign to the promoters of said event, including Quiksilver, the North Shore Lifeguard Association, Hawaiian Water Patrol, City and County of Honolulu, the State of Hawaii, and the sponsors, the exclusive commercial use of all photographs and photographic reproductions, television and motion pictures taken of me during the competition at this event, whether in or out of the water. I also agree to conduct myself in a professional, sportsmanlike manner prior to, during, and after the bodysurfing competition and while I am in the vicinity of the event. I have had an opportunity to be appraised of, and to review all the rules and regulations applicable to the competition and understand that any violation of these rules, or any unsportsmanlike conduct, will be cause for immediate disqualification from this contest by sole discretion of the contest director. I also agree to compete and appear in competition attire provided by the sponsors from time of issuance until completion of competition and during awards presentations.
